### **Task Force Updates**

#### COLORADO COVID LEGAL RELIEF

Since June 2020, the Colorado Lawyers Committee has partnered with the Colorado Attorney General, the Office of Economic Development and International Trade (OEDIT), the CBA/DBA, the Denver Chamber and the law firms of WilmerHale, Davis Graham & Stubbs LLP and Messner Reeves LLP to provide legal help for small businesses adversely impacted by COVID. Small businesses provide half of Colorado's jobs and have been especially hard-hit by the COVID-19 economic crisis, with minority and women-owned small businesses being hit the hardest. In the year since the program began, more than 250 small businesses have been helped through the program. As we start to recover from the pandemic this program will transition into the Colorado Small Business Legal Project (see below).



#### COLORADO SMALL BUSINESS LEGAL PROJECT

#### **DENVER LEGAL NIGHT**

Since April 2020, Denver Legal Night clinics have been offered remotely, on the first and third Wednesday of every month from 5 to 8 PM. The virtual clinics continue to be a success and have served over 1,500 people. Instead of meeting in person at Centro San Juan Diego, volunteer lawyers consult over the phone to help determine significant legal issues, refer individuals to legal services, and answer other questions about the legal process. #### FOSTER CARE SUBCOMMITTEE


The Foster Care Subcommittee has been meeting with the State regarding what we allege is the State's failure to provide appropriate placements for foster children in detention and required mental health services. Negotiations continue as the group tries to find a resolution.

#### HATE CRIMES EDUCATION TASK FORCE

The <u>Hate Crimes Education Task Force</u> recently converted its presentation so it is available virtually. In May, we presented the virtual program to 83 seventh graders! #### ICE IN THE COURTHOUSE SUBCOMMITTEE OF THE IMMIGRATION TASK FORCE

In early 2020, the ICE in the Courthouse Subcommittee successfully supported the passage of SB20-083 which prohibits ICE arrests at the courthouse and prohibits arrests of individuals traveling to and from courthouses. The goal of the law is to ensure a better functioning justice system in Colorado by protecting immigrants who go to courthouses from fear of arrest when they report crimes or appear as witnesses. The Subcommittee has been working with the Immigration Law & Policy Clinic (ILPC) at the University of Denver Sturm College of Law to educate Colorado sheriffs and judges about the new law. Once the courts reopen, the CLC will monitor ICE's compliance with the statute and may pursue litigation, if necessary. We have posted information on know if they learn of violations of this law.



#### SPECIAL IMMIGRANT JUVENILE STATUS (SIJS)

The Colorado Lawyers Committee is partnering with the Rocky Mountain Immigrant Advocacy Network (RMIAN) to train non-immigration lawyers to represent children in the state court SIJS proceedings. The training is free for anyone who agrees to accept an SIJS case screened by RMIAN. The virtual training will be in two parts: August 25th from 9 am to 11 am and September 10th from 9 am to 12 pm. Volunteers will have a mentor to assist them as necessary. <u>Click here</u> to sign up.

#### NONPROFIT LEGAL AUDIT CLINIC

The Nonprofit Legal Audit Clinic was held on July 20th via Zoom. Forty-eight volunteer lawyers met (in virtual breakout rooms) with representatives from 18 small nonprofits to assess the legal health of their organizations. The day began with a CLE for the attorneys. Thank you to our CLE presenters, all our volunteers and to the Steering Committee members for organizing such a wonderful virtual event! # Task Force Updates (cont.)

#### **RACIAL JUSTICE**

The Racial Justice Task Force was created in fall 2020 to assure that we are doing all we can to promote racial justice. More than 30 volunteers signed up to serve on three dynamic subcommittees: (1) The Advocacy Subcommittee, chaired by Martha Fitzgerald (Brownstein Hyatt Farber Schreck, LLC) is exploring needs in the areas of criminal justice, mental health and health care and will decide whether the CLC should create task forces in those areas. (2) The Training Subcommittee, chaired by Regina Rodriguez (WilmerHale), is planning DEI trainings for CLC staff and volunteers. (3) The Internal Subcommittee, chaired by Christine Hernandez (Hernandez & Associates, PC), will conduct a survey of DEI in CLC contributing law firms, is meeting with Specialty Bar Presidents to discuss strengthening their relationships with the CLC, and is planning a YLD Racial Justice Summit with YLD members from all organizations on September 8th.

#### **CRIMINAL JUSTICE TASK FORCE**

This new task force is looking at whether school districts are improperly releasing confidential student records to law enforcement.

#### THE MEDICAID/MENTAL HEALTH PARITY TASK FORCE

This new task force is exploring whether the state is complying with the Colorado and federal laws that require parity between medical services and behavioral health services available through Medicaid.
