On October 21, 2021, almost 400 lawyers and community leaders gathered to celebrate the accomplishments of Colorado Lawyers Committee volunteer attorneys and law firms, many of which were honored at the 2021 Awards Luncheon. During 2019 and 2020, more than 2,000 volunteers donated more than 15,000 hours and over \$6 million worth of time through the Colorado Lawyers Committee's 29 active projects in the areas of Children's Rights & Education, Civil & Criminal Law, Poverty & Public Benefits, Community Development, and Immigration. **Keynote speaker Lee Gelernt**, Deputy Director of the American Civil Liberties Union Immigrants' Rights Project and Director of the project's Access to the Courts Program, inspired the luncheon audience.

Task Force Updates

COLORADO SMALL BUSINESS LEGAL ASSISTANCE PROGRAM

Beginning in 2020, the Colorado Lawyers Committee participated in a very effective partnership, Colorado COVID Legal Relief (CCLR), that served over 250 small businesses struggling during the first year of the pandemic. In July 2021, the CLC led the creation of a new long-term partnership (Colorado Small Business Legal Assistance Program) to assist small businesses (primarily those with 10 or fewer employees) with their economic recovery and success. Volunteer attorneys provide one hour of free legal assistance to answer questions from small businesses on a range of legal issues. The program is housed at the Colorado Office of Economic Development and International Trade. The other program partners are the Colorado and Denver Bar Associations, the Asian Pacific American Bar Association of Colorado, the Sam Cary Bar Association, the Association of Corporate Counsel-Colorado Chapter, the Colorado Hispanic Bar Association, the Colorado Women's Bar Association, and Legal Entrepreneurs for Justice. Almost 100 volunteer attorneys have already agreed to participate. If you want to participate, you can sign up here.



FOSTER CARE SUBCOMMITTEE

In 2018, this subcommittee of the CLC Children's Task Force partnered with Children's Rights, a national nonprofit which advocates on behalf of abused and neglected children throughout the country, to explore possible litigation regarding the State's failure to provide appropriate placements and mental health services to youth involved in the child welfare and juvenile justice systems. The Subcommittee was concerned that these youth were being housed illegally in detention facilities after their release had been ordered and were not receiving adequate mental health support. In 2021, the Colorado legislature passed a bill that will likely resolve the placement issues raised by the Subcommittee. The State also recently implemented new policies and procedures regarding mental health which they think will reduce the problems they have faced in the past. After many months of negotiation with the State, the Subcommittee agreed to withdraw its concerns; Children's Rights will monitor the State's progress.

HATE CRIMES EDUCATION TASK FORCE

For more than 27 years, volunteers have presented an educational program on Colorado's Hate/ Bias Motivated Crimes Statutes to schools and community groups around the state. Using a fictional trial format involving a high-school student charged with hate crimes against a Muslim teacher, a perceived LGBT student and others (including by way of a social media threat), the presentation empowers student participants to act as jurors to improve their community culture in areas concerning discrimination, stereotyping, bias and inclusion and to prevent the severe harm caused by hateful slurs and biasedmotivated actions. While the pandemic significantly reduced the number of opportunities to present the Hate Crimes Program in person, the Task Force was able to modify the



program and has offered it virtually since 2020. The team is ready to provide a virtual or in person presentation to any school that is interested. If you know of schools that might want this free program, please contact Connie Talmage or refer them to the CLC website.

EDUCATION TASK FORCE

The Education Task Force met recently and will be working through four subcommittees for the near future: The Special Education Subcommittee is exploring challenges to the State's limited funding for special education programs. The School Discipline Subcommittee will explore possible interventions in the school to prison pipeline that disproportionately impacts students of color. The Charter School Subcommittee will examine the status of charter schools in Colorado and whether they satisfy legal requirements for serving students with disabilities. The School Finance Subcommittee is exploring possible action to assure that schools are adequately and fairly funded. IMMIGRATION TASK FORCE

The Immigration Task Force has been very busy. The Task Force recently created a new subcommittee to assist with the legal needs of Afghan refugees; Denver is expecting to receive around 2,000 Afghans in the coming months, many of whom will need help with asylum and other applications. The Task Force also recently partnered with Rocky Mountain Immigrant Advocacy Network to offer a virtual training for non-immigration attorneys who want to represent families seeking asylum before the Denver Immigration Court. In May 2021, the Department of Justice rocky mountain immigrant advocacy networks.



selected Denver as one of just eleven cities across the U.S. to pilot an expedited docket for newly arrived asylum-seeking families. With no appointed counsel in immigration proceedings, most families are now forced to navigate these high-stakes, complex and adversarial proceedings entirely on their own. The training is free for attorneys who agree to take a pro bono case through RMIAN. Visit the CLC website for more information.

RACIAL JUSTICE TASK FORCE

In response to recent events in our country, including the tragic death of George Floyd and so many more, the Colorado Lawyers Committee formed the Racial Justice Task Force in the Summer of 2020, in order to reassess our internal and external racial justice practices. Since it was formed, the Task Force has focused primarily on CLC internal structure and operations, to assure we are doing all we can in support of racial justice. The Task Force has focused on strengthening our relationships with the specialty bar associations (all of whom have a representative on the CLC Board) and expanding our outreach to diversity organizations at the law schools (so they are aware of CLC internship and volunteer opportunities). The Task Force plans to survey CLC contributing firms regarding best EDI practices and is also identifying minority law firms not currently active in the CLC. In September 2021, the Task Force co-sponsored, with the CLC Young Lawyers Division, a highly successful YLD Racial Justice Summit on the topic of racism in the criminal justice system. TAYLOR RANCH LITIGATION

The Taylor Ranch litigation (*Lobato v. Taylor*) involves the right of landowners in the San Luis Valley to access a 77,500-acre mountainous parcel known as the Taylor Ranch. This right was created in the mid-1800's when settlers on the Sangre de Cristo Land Grant, then a part of Mexico, were promised access to the mountainous regions near their homes for uses necessary for their survival. The first phase of the litigation (which began in 1981) ended in 2018 when the Colorado Court of Appeals rejected the ranch owner's efforts to limit the rights of the landowners. In recent years, however the ranch owner has engaged in numerous practices which limit the rights of the landowners. A stellar team from Ballard Spahr filed a motion on behalf of Plaintiffs objecting to these harassing practices and the court recently held a two-day hearing. Here's a link to a PBS story on this hearing and to two stories in *Law Week Colorado* (September 21, 2021 and October 18, 2021). In the interim, the ranch owner has filed several lawsuits against individual landowners, including a trespass action that asks for declaratory relief and specifically impacts the class rights, as well as a quiet title action of a class member. The individual landowners cannot afford to defend these actions. We are deeply concerned that these individual actions may erode (and conflict with) the rights we have been working to preserve for the last 40 years. Sherman & Howard L.L.C. agreed to take on representation of these individual landowners.
