Project Homeless Connect. The 5th Annual Project Homeless Connect was held on October 19, 2007 at Invesco Field at Mile High. Project Homeless Connect links over 1,000 homeless individuals in Denver to housing, employment, medical services, public benefits, and many other valuable services. Volunteer lawyers and law students generously donated their time to provide legal information and referrals. With the assistance of our volunteers, almost 200 Project Homeless Connect participants were provided information about family law, housing, immigration, bankruptcy, and much more.

Additionally, volunteers participated in the highly successful **Homeless Court**. Denver County Judge Ortiz-White spent over 5 hours resolving outstanding tickets and warrants for Project Homeless Connect participants. By the end of the day, thousands of dollars in outstanding fines were waived, community service hours were completed, and homeless individuals left with a concrete plan to end their homelessness. **Thank you to all our volunteers!**

Election Task Force. Representatives from the Election Task Force met recently with the Denver Clerk and Recorder, Stephanie O'Malley, to discuss ways the Task Force can be of assistance and help the City avoid problems with future elections. Mental Health Task Force. This Task Force is currently exploring legal issues on three separate fronts: children's mental health care, preventative mental health care, and the interplay between mental health care and the criminal justice system.

The Criminal Justice subcommittee is closely tracking three pieces of anticipated legislation for 2008. The first two bills would broaden last year's legislation that required the Department of Corrections to assist inmates with the application process for mental health services prior to release. These bills would extend the same legal requirement to jails and human service facilities, including youth correctional facilities and state hospitals. The third bill would require the state of Colorado to suspend (rather than terminate) an inmate's Medicaid benefits upon incarceration. This bill would make it easier for an inmate to receive Medicaid services upon release.
