# Michael J. Williams, United States Citizenship and Immigration Services, Community Relations Specialist

Mr. Williams began his career in public and community relations as a Radio and Television Broadcaster in the U.S. Air Force Public Affairs field in 2006. He served in Italy, Iraq, Maryland, and Colorado during his time in the Air Force. After leaving the Air Force in 2012, he worked as a Community Engagement Regional Coordinator for Denver Public Schools. Mr. Williams has also held positions with the U.S. Army, the Colorado Public Employees' Retirement Association (COPERA) and U.S. ICE Community Relations.

He is graduate of the Community College of the Air Force and Ashford University and earned his MBA in 2014 from Regis University.

### Jane Waterman-Joyce

As a hybrid employment and immigration attorney, Jane Waterman-Joyce focuses her energy on developing solutions for employers with a global workforce. This includes delivering creative solutions for work authorizations, advising employers on compliance matters, and assisting clients in filing for employment-based visas. One creative solution for a nonprofit employer involved filing Temporary Protected Status and work authorization applications for the employer's Ukrainian workforce, who had been stranded in the U.S. when Russia invaded. Because of this experience, Jane now coordinates with other attorneys to provide training on Temporary Protected Status applications and work authorizations for those who have received or are anticipating a grant of Temporary Protected Status.
